§ 1 Scope of this disclaimer

For the use of this Facebook page, the following terms of use apply between the user and the operator of the fan page (hereinafter referred to as "provider").

Use is only permitted if you, as the user, accept these terms of use.

§ 2 Liability notice regarding content on our Facebook page

The content of this Facebook fan page is created with the utmost care. However, the provider makes no guarantee that the content provided is accurate, complete and up to date. Use of the content of the Facebook page is at the user's own risk. Any posts identified by name reflect the opinion of the respective author and is not always the opinion of the provider.

§ 3 External links on our Facebook page

This Facebook page contains links to third-party websites ("external links"). Liability for these websites rests with their respective operators. When first setting up the external links, the provider checked the external content for any statutory violations. No statutory violations were apparent at that time. The provider has no influence whatsoever on the current and future configuration or on the content of the sites to which links are provided. The setting-up of external links does not mean that the provider espouses the content behind the reference or link. The provider cannot reasonably be expected to constantly review the external links if there are no specific indications of statutory violations. However, if the provider learns of any statutory violations, such external links will be deleted immediately.

§ 4 Obligations as user of our Facebook page

- (1) As the user, you undertake not to publish on our Facebook page any posts / comments which violate these rules, offend common decency or otherwise contravene current German law. You are in particular prohibited from:
 - publishing offensive or untrue content;
 - using content protected by law, in particular by copyright and trade mark law, without authorisation;
 - performing anti-competitive acts;
 - advertising on the Facebook page without the express written permission of the provider. This also applies to so-called surreptitious advertising such as, in particular, linking your own page or website with or without accompanying text in comments or within posts.
- (2) The provider has the right to delete posts and comments if they might contain a statutory violation.

Users of our website, on which the Facebook plugin is installed, are hereby informed that the plugin establishes a connection to Facebook, whereby a transmission to your browser is carried out so that the plugin appears on the website.
- (2) Use also forwards data to the Facebook servers, which contain information on your site visits to our homepage. For logged-in Facebook users, this results in the usage data being assigned to their personal Facebook account. As soon as you actively use the Facebook plugin as a logged-in Facebook user (e.g. by clicking on the "Like" button or using the comment function), this data is transferred to your Facebook account and published. This can only be avoided by logging out of your Facebook account in advance.
- (3) We do not know exactly what data Facebook stores and uses. As a user of our page, you must therefore expect that Facebook also stores all of your activities on the page.
